# ITEMIZATION OF SERVICES

*Tri-State Cremation Society of Delaware Valley is an internet based cremation society that provides cremation services and merchandise only. Although this General Price List refers to burial services and merchandise, we do not provide such services or merchandise. Burial services and merchandise are included in this General Price List because it is required by the Federal Trade Commission's Funeral Rule.*

*The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.*

Basic Services of Funeral Director and Staff .....\$2,245

Our fee for basic services of the funeral director and staff includes, but is not limited to:

Responding to the initial request for service; conducting the arrangement conference, preparation of biographical and statistical data; examination of financial settlement options; preparation and filing of papers, permits and authorizations; coordination with those providing other services; preparation and placement of obituary notices; retention and care prior to commencement of services; overhead expenses relative to our facility and operations such as occupancy, administrative and equipment costs. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains).

Embalming Care .....\$795

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Delaware Regulations, Title 16, Section 4204, "Regulations Governing Care and Transportation of the Dead," Section 3, as defined by the Delaware State Board of Health, requires that within 24 hours of removal, the remains of a human being be:

(a) embalmed,

(b) buried,

(c) cremated,

(d) encased in a hermetically-sealed casket not to be opened thereafter, or

(e) placed in controlled temperature environment.

Cremation Care .....\$495

Cremation care includes placement of the deceased person into the crematory chamber, the cremation process, coroner's fees, removal and retrieval of the cremated remains from the cremation chamber, uniform processing of the cremated remains and placement into designated urn(s). All steps are methodically and exclusively carried out by our team of *Cremation Association of North America* Certified Crematory Operators.

Use of Facilities and Staff for Viewing/Visitation at Funeral Home or Other Facility.....\$400

Services include set-up of the visitation area, placement of remains, positioning of floral displays, supervision and attendance during the hours of visitation, and parking lot assistance. This charge also includes local transportation from and to other facility as well as final committal.

Use of Facilities and Staff and Equipment for Funeral Ceremony at Funeral Home/Gathering/Memorial Service.....\$400

Services include set-up of the visitation area, placement of remains, positioning of floral displays, supervision and attendance during the hours of visitation, and parking lot assistance, arrangement and supervision of memorial service/ceremony/gathering as well as final committal.

Forwarding of Remains to Another Funeral Home.....	\$1,795
----------------------------------------------------	---------

This charge ***Includes*** transfer of remains to funeral home, basic services of funeral director and staff, embalming, coordination with providers of other services, and transferring the remains to the airport or other destination. It ***does not Include*** a casket or alternative shipping container, the use of facilities and staff for any visitation or ceremony prior to forwarding the remains or any sheltering of remains, or the charges of a common carrier.

Receiving of Remains from Another Funeral Home .....	\$1,795
------------------------------------------------------	---------

This charge includes receiving the remains from the other funeral home, the overnight sheltering of the remains, basic services of funeral director and staff, the obtaining of necessary permits and authorizations, and the local (within 25 miles) transportation to the cemetery or crematory. This charge does not include the use of facilities and staff for any visitation or ceremony. Nor does it include transferring of remains from the airport or other source, or the charges of a common carrier.

Direct Cremation.....•.....	\$1,595 to \$1,795

Our charges for direct cremation include basic services of funeral director and staff, the local (within 25 miles) transfer of remains to the funeral home, the overnight sheltering of the remains, refrigeration for up to two days, the obtaining of necessary permits and authorizations, photo identification only, local transportation to the crematory and charges for the cremation process. This charge does not include the use of facilities and staff for any visitation or ceremony, public or private, prior to cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are constructed of cardboard.

Our charges for immediate burial include basic services of funeral director and staff, the local (within 25 miles) transfer of remains to the funeral home, the overnight sheltering of the remains, the obtaining of necessary permits and authorizations, and local transportation to the cemetery, sanitary care and preparation of remains for identification. This charge does not include the use of facilities and staff for any visitation or ceremony. Nor does it include the actual cost of the grave at the cemetery, or the cemetery charge for opening and closing the grave.

If unembalmed body is to be taken outside of funeral home for service other than graveside service, a minimum-sealing casket or wooden casket with sealed metal inner liner is required.*
